



PROMOTIONAL TERMS AND CONDITIONS FOR CUSTOMERS

Competition Description

Acceptance of Conditions

5. By entering into this competition, you are deemed to accept these terms and conditions.

Promotional Period and Method of Entry

6. The promoter is Powerbase Ltd of Unit 1, 202 Wooldridge Road, Harewood, Christchurch ("**Promoter**").
7. Individual Powerbase Members may elect whether or not they wish to participate in this competition. A Powerbase Member who elects to participate in this competition is a "**Participating Powerbase Member**". It is the responsibility of the customer to check with its Powerbase Member whether it is a Participating Powerbase Member for the purposes of this competition.

Conditions of Qualifying Purchases

16. All Qualifying Purchases are subject to the terms and conditions of sale of the relevant Powerbase Member except that no credit for a Promotional Product generating a Qualifying Purchase is permitted.
17. Where you receive a quote from a Powerbase Member for the Promotional Product in connection with a specific project, any resulting purchase of Promotional Product will not constitute a Qualifying Purchase for the purposes of this competition.
