



PROMOTIONAL TERMS AND CONDITIONS FOR CUSTOMERS

Competition Description

Acceptance of Conditions

Promotional Period and Method of Entry

6. The promoter is Powerbase Ltd of Unit 1, 202 Wooldridge Road, Harewood, Christchurch ("**Promoter**").
7. Individual Powerbase Members may elect whether or not they wish to participate in this competition. A Powerbase Member who elects to participate in this competition is a "**Participating Powerbase Member**".
