

# PROMOTIONAL TERMS AND CONDITIONS FOR CUSTOMERS

### **Competition Description**

## **Acceptance of Conditions**

### **Promotional Period and Method of Entry**

- 7. Individual Powerbase Members may elect whether or not they wish to participate in this competition.
