

PROMOTIONAL TERMS AND CONDITIONS FOR CUSTOMERS

Promotion Description

Acceptance of Conditions

Promotional Period and Method of Entry

- 6. The promoter is Powerbase Ltd of 1/202 Wooldridge Road, Harewood, Christchurch ("Promoter").
- 7. Individual Powerbase Members may elect whether or not they wish to participate in this promotion. A Powerbase Member who elects to participate in this promotion is a "Participating Powerbase Member". It is the responsibility of the customer to check with its Powerbase Member whether it is a Participating Powerbase Member for the purposes of this promotion.

- 9. The promotion commences 1 January 2025 and finishes the 28 February 2025 (the "Promotional Period") or while stocks last.
