

# **PROMOTIONAL TERMS AND CONDITIONS FOR CUSTOMERS**

## **Competition Description**

1. Every contractor purchase of Glight product to the value of \$500 + GST net on one invoice will go into a national draw to win one of 20x places to the Warriors vs Dolphins NRL game.

#### Acceptance of Conditions

2. By entering into this competition, you are deemed to accept these terms and conditions.

#### **Promotional Period and Method of Entry**

- 3. The promoter is Powerbase Ltd of 1/202 Wooldridge Road, Harewood, Christchurch ("Promoter").
- 4. Individual Powerbase Members may elect whether or not they wish to participate in this competition. A Powerbase Member who elects to participate in this competition is a "**Participating Powerbase Member**". It is the responsibility of the customer to check with its Powerbase Member whether it is a Participating Powerbase Member for the purposes of this competition.
- 5. Entry to this competition is open to customers of Participating Powerbase Members.

- 7. - 15. Where you receive a quote from a Powerbase Member for the Promotional Product in connection with a specific project, any resulting purchase of Promotional Product will not constitute a Qualifying Purchase for the purposes of this competition.
